RANDOLPH COUNTY COMMISSION SS:

At a regular session of the County Commission in and for the aforesaid County and State, at the James F. Cain Court House Annex, on the 19th day of September, 2024 at 1:30 p.m.

Present: Randolph County Commission President, Chris Siler and Randolph County Commissioners, David Kesling and Chris See.

Meeting called to order by Commissioner Siler

PUBLIC COMMENT: None

MINUTES:

Commissioner Kesling moved to approve the minutes from the regular meeting that was held on September 5, 2024, as submitted. All yes – Motion passed unanimously

REPORTS:

Erin Golden, Director of North Central Community Corrections, dropped off a report to the Commission. There are currently 120 participants on the program and the program has saved the County \$429,465.84 in regional jail bills this fiscal year.

Sheriff Elbon reported that he is going to be out of service for a while. He said he is going to Charlottesville for ankle revision surgery next week. He said he won't be able to drive for a while.

Lieutenant Talkington appeared before the Commission to give a report on the body cams. He said he wasn't there to ask for any money. He said with the contract on the body cams halfway thru the contract they can get upgrades. He said Axon came up with newer model body cams. He said they talked it over and decided to get them. He said the only thing they need for the new ones is a new docking system. He said GST might have to do an upgrade but that would be all. He said they can also get additional accessories and they are looking at that. He said the new body cams will show more area in the frame. He said the shut off switch was also changed and the battery life is two years.

Commissioner See asked if the body cams had been beneficial. Lieutenant Talkington said yes very much so. He said the Attorney's use them on their cases and when he does a report he can be very accurate. He said it is a great asset for their department.

911/OEM Director Michael Miller gave a handout to each Commissioner of his report. He said they had a LEPC meeting yesterday and went over more planning for the Mountain State Forest Festival. He said he received a phone call from Mr. Posson which is the land owner that the Rich Mountain Tower sits on. Mr. Posson wants to increase the lease amount but the lease that was signed was for 20 years. Mr. Miller said Mr. Posson might try to call the Commissioners about it. He said he worked Monday on cleaning the brush and trees from the building at the Stuarts Knob tower. He said there is water coming into the building and there has been no maintenance done and the building is in need of repairs. He said there are still leaks in the roof at the 911 Center and Duarte's Roofing out of Clarksburg is still working to repair it. He said he is still working on a price list for Amateur Radio's for the OEM/911 Center in the event the radio communication would go down. He said Commissioner Siler and himself met with the Airport Authority and worked out plans to put the tower up at the 911 Center. He said Commissioner's Siler and See and himself met with Pendleton and Pocahontas County Commissioners and their OEM Directors regarding signing the Resolution of National Radio Quiet Zone.

County Clerk Brenda Wiseman gave an Election report. She said her office is working on receiving Absentee Ballot requests at this time. She said they have approximately 105 applications in so far. She said they will start mailing Absentee Ballots tomorrow September 20<sup>th</sup>. She said the last day someone can request an absentee ballot is October 30<sup>th</sup>. She said the poll workers lists are being approved today and letters will be mailed to each poll worker to accept the position. She said they will have a poll worker training and will let the poll workers know when that will be held. She said once her office receives everything they need they will begin testing the machines. She said there will be a public test

and everyone is invited to attend. She said she will announce when that will be held. She said the last day to register to vote or make any changes to your voter's registration is October 15<sup>th</sup>. She said Early Voting will begin on October 23 and run thru November 2<sup>nd</sup> at both locations as in the past. She said election day is November 5, 2024 and all polls will be open from 6:30 a.m. to 7:30 p.m. that day. She said the results will be read out loud in the Courtroom on election night and they will also hand out copies that night. She said the canvass will be held on November 12, 2024. She said they have sample ballots available now if anyone would like one.

ANNOUNCEMENTS:

Commissioner Siler announced that the next meeting of the Randolph County Commission will be held on October 3, 2024 at 1:30 p.m. in the Wees building. He said today's meeting is the last meeting in this room. He also announced that the courthouse and all annex buildings will be closed on Friday October 4<sup>th</sup> for the Forest Festival and Monday October 14<sup>th</sup> for Columbus Day.

Commissioner Kesling announced that the Enforcement Agency will meet on Tuesday October 15<sup>th</sup> at 11:00 a.m.

ITEMS FOR DISCUSSION/ACTION:

CONSIDER APPROVAL OF FUNDING REQUEST FOR YMCA FOR THEIR SEPTEMBER TO REMEMBER CONCERT (See copy attached)

Sid Gillispie, Executive Director of Elkins-Randolph County YMCA, appeared before the Commission. He said he was there regarding the September to remember concert that they are having tomorrow September 20, 2024. He said it will be held at the Citizens Bank of West Virginia Amphitheatre at Davis and Elkins College. He said last year they had around 650 people attend. He said it is free to the community. He said they are requesting \$5,000.00 from the Commission. Commissioner Kesling moved to approve the funding request from the YMCA in the amount of \$5,000.00 and that is to be taken out of Hotel/Motel Tax funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FOR YMCA FOR THEIR WATER FILTRATION SYSTEM (See copy attached)

Sid Gillispie, Executive Director of Elkins-Randolph County YMCA, appeared before the Commission. He said they need to replace the pool's filtration system at the YMCA. He said the existing system has reached the end of its operational life and is no longer able to meet the necessary standards for water quality and safety. He said the project is going to cost \$100,000.00. He said they are very appreciative of anything the Commission could do to help. Commissioner Kesling said they still have money left in the ARP funding and it can be used for non-profit agencies, which the YMCA is. Commissioner Kesling moved to approve the funding request from the YMCA for the water filtration system in the amount of \$25,000.00 and that is to be taken out of the ARP funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF PAYMENT TO THE INTERNAL REVENUE SERVICE OF UNPAID TAXES FOR WHITMER WATER ASSOCIATION

Jerry Roberts from the City of Elkins appeared before the Commission. She said they have not received a letter from the Internal Revenue Service with the full amount that the Whitmer Water Association owes. She said she would like the Commission to hold off until that is received. Commissioner Kesling said himself and Administrative Assistant Melinda Lott called the IRS on Monday and was told the amount of \$19,571.75 is the amount owed and that amount was good until October 25<sup>th</sup>. He said they also found out some quarters have not been filed yet so there will be more owed. He said it could take 5 days to get the letter. He said he would like to go ahead and pay what they owe now. He said they also talked to the State Tax Department and \$7,591.68 is owed to them and that amount is good thru October 4<sup>th</sup>. He said they will talk about that at the next meeting. Commissioner Kesling moved to pay \$19,571.75 to the Internal Revenue Service, out of coal severance funds, for Whitmer Water pending receipt of the letter stating amount. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF FY 2024 JAG GRANT APPLICATION

Commissioner Kesling moved to approve the JAG Grant Application, as submitted. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF FUNDING REQUEST FOR MOUNTAIN STATE FOREST FESTIVAL FIREMAN'S PARADE (See copy attached)

Commissioner Siler read the funding request letter from the Elkins Volunteer Fire Department. This is for the 86<sup>th</sup> annual Mountain State Forest Festival Fireman's parade. The Elkins Volunteer Fire Department feeds 200-300 firemen and gives out trophies and awards. They are asking for a \$1,500.00 donation. Commissioner Kesling moved to approve the funding request from the Elkins Volunteer Fire Department in the amount of \$1,500.00 and that is to be taken out of Hotel/Motel Tax funds. All yes - Motion passed unanimously

#### CONSIDER APPROVAL OF RELEASE OF FUNDING FOR THE RANDOLPH COUNTY AMBULANCE AUTHORITY (See copy attached)

Commissioner Siler said this is money that has already been budgeted for the Randolph County Ambulance Authority and they are just asking for it to be released to them with this letter. Commissioner Kesling moved to approve the release of funding in the amount of \$110,000.00 as budgeted for the Randolph County Ambulance Authority for FY2024/2025. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF RESOLUTION OPPOSING CONTINUED INTERVENTION IN PUBLIC SAFETY AND CELLULAR/WIRELESS COMMUNICATIONS BY THE NATIONAL RADIO QUIET ZONE (See copy attached)

911/OEM Director, Michael Miller appeared before the Commission. He said Randolph County will probably be the last County to sign this Resolution. He said all the other Counties have already signed. He said they are hoping to get the National Radio Quiet Zone lifted. He said they have been fighting this battle for years. He said this affects the emergency services responses to citizens. Commissioner See said a representative from Joe Manchin's office is involved so hopefully that helps. Commissioner Siler said hopefully this will help so we don't have to keep putting up towers. He said this should boost the power up. He said it's the first step in the fight. Commissioner See moved to approve the Resolution, as submitted. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF GROUND LEASE AGREEMENT FOR THE 911 CENTER

Commissioner Siler said this is a ground lease agreement with the Airport Authority to put the tower up at the 911 Center. He said they originally wanted \$500.00 per month, he asked for \$250.00 per month and they finally agreed to \$275.00 per month. He said the total is \$3,300.00 per year lease. He said Prosecuting Attorney Michael Parker reviewed it. Commissioner See moved to approve the ground lease agreement with the Airport Authority for the 911 Center tower in the amount of \$3,300.00 per year. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF POLL WORKERS FOR THE NOVEMBER 5, 2024 GENERAL ELECTION

County Clerk Brenda Wiseman presented the poll workers lists to the Commission. She said these are from the Republican and Democrat Executive Committees. Commissioner Kesling moved to approve the list of Democrat poll workers for the November 5, 2024 General Election, as submitted. All yes – Motion passed unanimously Commissioner See moved to approve the list of Republican poll workers for the November 5, 2024 General Election, as submitted. All yes – Motion passed unanimously

#### CONSIDER RATIFICATION OF SIGNATURES ON THE PRO GRANT AWARD

Sheriff Elbon said this is the PRO Grant that Rocky Hebb applied for and received \$30,000.00 for the PRO Officers in the schools. He said this is just the paperwork that needs signed to accept the \$30,000.00 grant. Commissioner Kesling moved to approve ratifying the signatures on the PRO Grant award, as presented. All yes – Motion passed unanimously

CONSIDER APPROVAL OF CITYNET LEASE AGREEMENT FOR NEW LINE IN PROSECUTOR'S BUILDING

Commissioner Kesling said this is for the new employee at the Prosecutor's Office. There needs to be another phone line added. Commissioner Kesling moved to approve the lease agreement with Citynet for the new phone line in the Prosecutor's Office. All yes – Motion passed unanimously

CONSIDER APPROVAL OF SCOREBOARD PURCHASE FOR ELKINS LITTLE LEAGUE (See copy attached)

Commissioner Siler said he spoke to Leah Shepler, President of Elkins Little League Board of Directors, about this. He said they are hoping to have state tournaments here next year. He said they needed to get three new scoreboards for all three baseball fields. He said they secured enough donations to buy two of the scoreboards but need help buying the third one. Commissioner Siler moved to approve the funding request from the Elkins Little League in the amount of \$6,610.87 for the purchase of a new scoreboard and that is to be taken out of Hotel/Motel Tax funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF DISBURSEMENT OF FUNDING FOR AIRPORT TOWER

911/OEM Director, Michael Miller appeared before the Commission. He said the tower for the 911 Center has been laying up there for 3 years with nothing done. He said the concrete pad needs poured before it can be put up. He said they finally got the approval from the Airport to use the property to put the tower on. He said it was originally going to be an 80 foot tower but it had to be changed to a 70 foot tower. He had invoices from Premier Construction Group, LLC out of Jane Lew, WV. Discussion followed. It was determined that some of the fees had already been paid. It was decided to wait and talk to Premier Construction Group, LLC and figure out exactly how much is still owed. Commissioner Kesling moved to table this item. All yes – Motion passed unanimously

## **A RESOLUTION BY THE RANDOLPH COUNTY COMMISSION OF WEST VIRGINIA OPPOSING CONTINUED INTERVENTION IN PUBLIC SAFETY AND CELLULAR/WIRELESS COMMUNICATIONS BY THE NATIONAL RADIO QUIET ZONE**

**WHEREAS**, it is the mission of the Randolph County Commission, West Virginia (RCC) to provide for the safety and security of our county citizens, to include providing direct law enforcement and emergency management/911 functions, as well as communications support to all county Fire and EMS agencies;

**WHEREAS**, RCC believes that the National Radio Quiet Zone (NRQZ), whose regulations were first adopted in the late 1950's has not kept pace with the modern wireless communications tools used by first responders and our citizens;

**WHEREAS**, the NRQZ is an ever-growing unfunded federal mandate on our county emergency services/911 operation wherein it causes us to spend large amounts of funding building a larger number of tower sites than would be needed absent the NRQZ restrictions;

**WHEREAS**, RCC believes that the NRQZ Agencies should fully fund and support filtration of unwanted signals at the head-end of the NRQZ-Agency equipment and not by unfunded mandates of reductions and nulls of signal imposed on the public safety, cellular and satellite internet providers;

**WHEREAS**, the NRQZ inhibits widespread growth of commercial cellular/wireless systems throughout Randolph County, thereby greatly diminishing the use of AT&T First Net and similar systems by first responders and commercial cellular systems by our current and prospective citizens, businesses, and tourists, all to the detriment of our economic well-being;

**WHEREAS**, Randolph County is highly-impacted in a negative and unfunded way by the NRQZ, placing us at an unfair disadvantage to areas outside the NRQZ, with no consideration or support from the federal government.

**NOW, THEREFORE, BE IT RESOLVED**, that RCC shall voice its opposition to continued enforcement of NRQZ restrictions absent significant federal funding to allow us to better meet said restrictions; further:

**BE IT RESOLVED** that RCC prefers dissolution of the NRQZ. Absent such dissolution, RCC fully supports total waivers of any NRQZ restrictions imposed on Public Safety Radio Frequency Bands currently in use, as well as all the commercial cellular/wireless Bands, and commercial satellite internet providers, such as Starlink, throughout the entire NRQZ; and

**BE IT FURTHER RESOLVED** that RCC shall convey its opposition to the NRQZ and its request for immediate federal assistance to the members of the United States Congress and Executive Branch. This resolution shall take effect immediately upon adoption and entry thereof.
