At a regular session of the County Commission in and for the aforesaid County and State, at the James F. Cain Court House Annex, on the 20th day of January, 2022 at 1:30 p.m.

Present: Randolph County Commission President, Chris See and Commissioners, David Kesling and Chris Siler.

Meeting called to order by Commissioner See

#### PUBLIC COMMENT:

Richard DeBias said he was there again to talk about body cams and wanted to make it crystal clear to everybody that anybody he mentions during his speeches, if they were sitting here right next to him in a chair he would say the same thing. If he makes some people upset he is not going to really apologize that's the way it's going to be. He said he thinks he sent some stuff to the Commissioners and Sheriff about body cams in Weirton. He said they are getting body cams over there and they are getting body cams all over the Country. He just feels there is a lot of money for body cams here and he just doesn't know the reason nobody is getting them. He said every time he brings it up he gets totally ignored, he has tried for over a year he said. He said he personally feels there is a little bit way too much favoritism to the law enforcement, that's his opinion, with exception of Commissioner Siler who he said he does not have a grievance with and does not know who he is. He said the Sheriff has been the most transparent guy he has dealt with in the over 21 years he has been here. He has to give him credit for that. He said the rest of the people he has dealt with in the past have been totally incompetent, most of them are just there milking the system and for free publicity. He said it seems like out there in the community since he got hurt, and had to deal with it, before he didn't bother anybody, 50% of the population is barely surviving in Randolph County other 40% don't care and the other 10% are right here in town and all stick together. He said everybody is aware of what happened to him, Talkington, Knotts and Pennington came to his house. He said Talkington came in there with an Agenda, he doesn't know what his purpose was or why he had anything against him, but he did. He said he got a charge he shouldn't have got and his family got harassed. He said he doesn't know how many other people he has done that to. He said he went across the street to Magistrate Dyer and Shepler and they all stick together then he went to the Prosecutors who helped them, Parker and Poling, which he doesn't even know how they have a law degree, either one of them, but he guesses they do. He said if any of these people were in the real justice system they wouldn't even be relevant. He said they all rounded the wagons and stuck it to him. He said that's why he keeps coming back. He said he will keep attending meetings and trying to get the body cams and he will keep telling everyone he can about the injustice system here in Randolph County. He thanked them for their time and attention.

### MINUTES:

Commissioner Kesling moved to approve the minutes from the regular meeting that was held on January 7, 2022, as submitted. All yes – Motion passed unanimously

### **REPORTS:**

Rhett Dusenberry from Congressman Mooney's Office was present. He congratulated Commissioner See for becoming the County Commission President for 2022. He said the Congressman is always ready to do letters of support for any grants they want to apply for. He said to be safe on the roads in this bad weather. He also said the Sheriff is doing a good job.

Randolph County Sheriff, Rob Elbon gave a year- end report. He said he wanted the Commission to know they did apply for a grant for body cams but were denied. He said they had Peggy Ross help them with it and send it in but it was denied. He said they will look again to try to find something for body cams. He said for January 1, 2021 to December 31, 2021 they answered 5,233 calls last year. He said they investigated 463 cases, 715 offenses from those 463 cases. He said there were 569 misdemeanors

and 146 felonies. They arrested 215 individuals with 339 offenses. He said they made 62 drug arrests. He said there were 273 collisions with 176 accident reports done and 97 were with driver exchange of insurance information. He said they made 1,296 traffic stops last year with 314 citations issued with 394 violations and 360 were given warnings. He said the deputies did 172 civil process and 69 writs of execution and 103 misdemeanors. He said they did 76 transports last year with 27 of those being mental hygiene. He said total activity with traffic stops and everything was 6,529 that the Sheriff's office investigated or was involved in. Commissioner Kesling said Thank You to the Sheriff and said that he will never say he is sorry for supporting him or his deputies. He said until someone walks in their shoes and sees what they have to go through on a daily basis and that is why he will always support law enforcement. Sheriff Elbon said he and his deputies appreciate the Commission's support and they have been good to them and the public can see that and from that you can see the activity that comes from having the equipment and tools they need. He said these guys are dedicated, they love this County and they love the people in this County, and will continue to work to do the job.

Randolph County Clerk, Brenda Wiseman reported that the filing period for candidates wishing to run in the 2022 Election is now through January 29<sup>th</sup>. She said her office will be open on Saturday January 29<sup>th</sup> from 9:00 am to 12:00 pm for candidate filings. She said after that the certificate of announcement would need to be postmarked by midnight on January 29<sup>th</sup> to be accepted.

Commissioner Siler reported on behalf of Curt Gainer from the Randolph County Emergency Squad. He said Curt called him this morning and said he could not be here today because of shortage on manpower. He said they are out almost 50% with COVID. He said Curt said he needed to help with the calls instead of coming to the meeting today.

Sheriff Elbon said they have 1 out with COVID.

Angie Goff, GFWC Junior Woman's Club President, appeared before the Commission. She said this will be the 38<sup>th</sup> year for EHS project safe graduation. She said last year it was held at the Phil Gainer Center and it was great. She said they did a fire pit and the students loved it. She said they tried to keep everything local because of COVID. She said last year it cost \$16,000.00. She said they encourage the public to come and help them. She said there are only 8 of them doing the entire party. She said law enforcement and fire departments come and help them and they say they would rather be there than pulling the kids out of a wrecked car later. She said they would like to get a wrecked car and put it in front of the schools to show what could happen. She said attendance is usually about 50% but they want it to be higher. She said she always tells the story of how her classmates died. This year it will be held on May 27, 2022 at the Phil Gainer Center. Commissioner Siler moved to approve \$2,000.00 from courthouse contractual funds to EHS Annual Graduation Party. All yes — Motion passed unanimously

INFORMATIONAL PRESENTATION AND FUNDING REQUEST FROM KITTEN HOLLER

Abigail Hohn appeared before the Commission. She said she has started an animal rescue group based in Mill Creek and serving southern Randolph County. She said they are trying to get 501C3 status to be a nonprofit organization. She said Kitten Holler's mission is to help cats and humans in Randolph County by reversing the population growth of feral cat colonies, reducing death and suffering of homeless cats, finding adopters for kittens, and helping community members attain affordable veterinary care. She

said the funding request is in the amount of \$600.00 and that is the cost of the application to become a registered 501C3 nonprofit. She said once they become a registered 501C3 nonprofit organization they will be able to apply for dozens of national and regional grants. She said they trap feral cats and take them to the vet and have them spayed or neutered and then turn them back out where they were found. She said as for the kittens they try to get people to take them in and foster them or adopt them. She said in 2021 they had 42 cats spayed or neutered and 15 kittens adopted. She said so far this year they have had 7 cats spayed or neutered. She said right now they are paying for it through go fund me donations and she has also spent quite a bit of her own money. Commissioner Kesling moved to approve the funding request of \$600.00 to Kitten Holler and that is to be taken out of courthouse contractual funds. All yes — Motion passed unanimously

Dear Randolph County Commission,

Kitten Holler is a newly formed animal rescue group based in Mill Creek, West Virginia, and serving southern Randolph County. We would like to request that the Randolph County Commission fund our application with the IRS to become a registered 501 c (3) nonprofit. The cost of the application is \$600. The benefit to the community will greatly exceed the initial cost of registering with the IRS.

Kitten Holler's mission is to help cats and humans in Randolph County by reversing the population growth of feral cat colonies, reducing death and suffering of homeless cats, finding adopters for kittens, and helping community members attain affordable veterinary care. To meet these goals, we conduct trap-neuter/spay-return (TNR) of feral cats. We also rescue and socialize kittens for adoption.

Once Kitten Holler has become a registered 501 c (3), we will be able to bring funding into the county to address a problem that the community cannot afford to address on its own. Dozens of national and regional grant opportunities are only available to registered 501 c (3) institutions. We are confident that we will win several grants because our director, Abigail Hohn, has an extensive record of writing successful grant proposals, including winning two grants totaling \$33,000 for the Elkins-Randolph County Public Library in 2021. Kitten Holler will also be able to attract more substantial private donations as a 501 c (3).

Since forming in September 2021, Kitten Holler has relied on community donations and assistance from the Randolph County Humane Society. We have spayed/neutered over forty cats in Mill Creek, Beverly, and Elkins. Of those, fourteen were kittens who were rehabilitated and placed with adopters, five were pets whose owners needed financial assistance, and ten were feral cats who were relocated to barns. The remaining were feral cats returned to the area where they were trapped in accordance with accepted TNR practices. The Humane Society sponsored sixteen of those surgeries before running out of funds.

At the moment, Kitten Holler has a waitlist of over forty outdoor cats who need to be spayed/neutered, and there are several reports of large colonies that still need to be investigated. Our goal in 2022 is to maintain the same rate and spay/neuter 120 cats in Randolph County. The surgeries alone would cost approximately \$20,000. To cover this expense, Kitten Holler must be able to apply to grants open only to 501 c (3) nonprofits.

Benefits to the Randolph County community greatly exceed the initial cost of spaying/neutering 120 cats. Less property damage will be caused by cats, specifically females burrowing under structures to give birth. Smaller feral cat populations mean fewer birds killed by cats for food. Additionally, the Randolph County Humane Society will receive fewer requests to take in cats they do not have room to house. Finally, residents will not be as hard pressed to cover the cost of feeding homeless cats or their own pets birthing litters every year. Kitten Holler is an animal rescue group, but we care deeply that our services help our community, as well.


