At a special session of the County Commission held in and for the aforesaid County and State, at the Court House Annex, on the 16th day of May, 2022 at 9:00 A.M.

Present: Randolph County Commission President, Chris See and Commissioners David Kesling and Chris Siler

Meeting called to order by Commissioner See

Commissioner See announced that the purpose of today's meeting is to Canvass the election results from the Primary Election that was held on May 10, 2022.

Commissioner Kesling moved that for anyone that would like to request a recount the bond amount will be \$300.00.

All yes – Motion passed unanimously

Also present were County Clerk Brenda Wiseman, Maintenance Staff Shawn Ferguson and James Ramsey and Patricia Rossi, Democrat Ballot Commissioner and Administrative Assistant Brooke Hinzman

Commissioner Chris Siler drew Precinct #28A to be hand counted.

Clerk Wiseman presented the Commission with mailed absentee ballots that were received after Election Day, but before the start of canvass. The Commissioners reviewed each ballot to check the date it was postmarked and received by the Clerk's Office.

Commissioner Kesling moved to approve the nine (9) absentee ballots that were received in the County Clerk's Office on May 11, 2022, as submitted.

All yes – Motion passed unanimously

Clerk Wiseman presented the Commission with the paperwork for each precinct.

EARLY VOTING IN ELKINS had 1 provisional ballot.

Commissioner Kesling moved to accept the 1 provisional ballot. All yes - Motion passed unanimously

The results of precinct 28A did not change and it was determined that the machines tabulated correctly.

County Clerk staff entered the additional absentee ballots and provisional ballots at this time.

Commissioner Siler moved to declare the election results, at 11:10 a.m., of the Primary election that was held on May 10, 2022

County Clerk Wiseman said this will begin the 48 hour period for a recount. She explained that the Commission will have to meet again to certify the results.

Commissioner Kesling moved to adjourn the canvass.
