Present: Randolph County Commissioners, David Kesling and Chris Siler. Commission President Chris See was absent.

Meeting called to order by Commissioner Kesling

#### PUBLIC COMMENT:

Richard Debias appeared before the Commission. He said he wanted to come back one last time to cover a few things that he didn't get to cover in the August 4<sup>th</sup> meeting. He said he gave Ms. Hinzman exhibits 1 thru 18. He said he also gave the Sheriff exhibit 18 that deals with body cams. He said change happens from the bottom up, not the top down. He said in regards to his criticism, he only criticizes the supervision, he has nothing against the working base. He said he came back today because he didn't get to finish talking at the August 4th meeting because of the 5 minute time limit. He said with the Freedom of information Act requests that he turns in he still doesn't get back the exceptions, you have to site the exemptions, and he never gets that just gets told to go somewhere else. He said it seems like no matter what he does you guys do what you want. He said he guesses that is what he will have to do, do what he wants. He said he sent some emails and made some phone calls about the August 4th video and it was finally put up the other day. He said he never got any replies and he thought that was kind of rude. He knows people get busy but they could at least return something. He said he wants to talk about the injustice system in this County. He said he dealt with a civil suit and he had a Judge that was basically disgraced off the bench, then he had an Assistant Prosecutor they ran out of an adjacent County that is here now. He said then he had to go down to that clown show at the Tygart Valley Regional Jail where they have a real bad guy in charge of it. He said he has dealt with the City and County and the City blows you guys away. He said they return calls, the mayor and even the Chief of Police. He said he has lived here 22 years in this County and he has never seen so many corrupt liars and thieves in his life. He said they hide behind the bible, the kids and the flag. He said he is not going to sit back and take personal attacks because he is a counter puncher. He said that is hypothetically speaking because he isn't going to punch nobody. He said he come here for one reason today and he expects a personal apology from David Kesling because he was treated rude this whole time when he first came here to try to hash out his differences. He said Bryan Talkington needs to personally apologize to his wife, his kid and his mother in law because he forcefully harassed and threatened them. He said Alexa Poling needs to personally apologize to his wife for threatening her. He said then the last thing is the Sheriff, he needs to retract that statement he put in the paper because that was nothing but a hit job, it was nothing but a pack of lies, he wasn't even there. He said that is what he expects to happen and if it doesn't then he is going to do some counter punching and he doesn't want everybody melting like snow flakes when he starts doing it. He said the main thing is he is not hard to find, everybody knows where he lives and knows his address and email and phone number. He said he doesn't run from nobody in this County, never have and never will. He said the last thing he wants to say is to the powers to be in this County, and he isn't making any threats or nothing, but he is just saying people better stay away from his family because he has instructed all of them to crush this County legally and financially, so help him God.

ITEMS FOR DISCUSSION/ACTION:

### INFORMATIONAL PRESENTATION FROM HUTTONSVILLE PSD

Cory Weese, Chairman of the Board for Huttonsville PSD appeared before the Commission. He said the reason they came to the Commission today is to ask for help with funding for an inter connection with Huttonsville PSD, the Town of Mill Creek and the Town of Huttonsville. He said this would be a permanent connection so if the Town of Mill Creek would run out of water Huttonsville PSD could serve them. He said on that line is George Ward Elementary School, Tygarts Valley High School and Valley Health Care Clinic. He said he brought Kenna Chambers from Gosha Engineers to speak on their behalf. Mr. Kenna Chambers appeared before the Commission. He said sometime late last fall the Town of Mill Creek initiated a water distribution system project and they had approached the PSD concerning making a secondary connection to their system. He said at that time they told the Town of Mill Creek that they can't do this because where they were proposing to do the connection it would not be supported by the PSD. He said they don't have the water there and they are weak in the system. He said with that ,they submitted a proposal to the Town of Mill Creek, instead of making this connection here, why don't we make this a permanent connection where we can provide all the water and pressure that the town needs as originally intended when the new plant was built for Huttonsville PSD. He said that is about a million dollar project and that is what they are really here today about and what they have been really pushing the town to go towards. He said this would also benefit the correctional center, Town of Huttonsville, Town of Mill Creek and Huttonsville PSD. He said when you start to go back and look at all the previous documents you will find that all back in the late 90's and early 2000's all the communities and even the County Commission were in a partnership to move forward with this plan. He said this plan was to build a treatment plant to provide water essentially all the way up to the City of Elkins. He

said this is what was intended when this treatment plant was built and they would just like some assistance from the community to try to put these things in place at this point. Commissioner Kesling said they have already gave Huttonsville PSD money from the ARP funding and the ARP funding has already been used up. He said they need some kind of number to work with. Mr. Chambers said the inter connection is estimated to cost one million dollars. He said any kind of grant funding would be great. Commissioner Kesling said they could check with their grant writer to see if there are any grants out there. Commissioner Siler said it takes about a year to get the money from any grants that they do. Commissioner Kesling said they are not against it but don't have any money to give right now. Mr. Chambers said even if the County Commission could get back in touch with the communities and tell them this is what needs to happen, that would help.

CONSIDER APPROVAL OF FUNDING REQUEST FROM TYGART VALLEY HOMESTEAD ASSOCIATION (See copy attached)

Gloria Collett and Maggie Bennett appeared before the Commission. Ms. Bennett said they had requested \$25,000.00 in funding at the last meeting for revenue replacement from ARP funds. She said they are trying to get the building up and running. She said in 2019 they had just started fundraising and COVID hit. She said in 2020 they were shut down and in 2021 people were still leery to come out. She said in 2022 they are doing much better and having events now. She said it has taken volunteers a lot of hours of work. She said they are doing everything possible to keep the building going. Commissioner Siler moved to approve the funding request from Tygart Valley Homestead Association in the amount of \$15,000.00 and that is to be taken out of the ARP funds. All yes — Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM DRY FORK RECREATION CENTER (See copy attached)

Rex Vance, President of Dry Fork Recreation Center, Inc. appeared before the Commission. He thanked the Commission for their help in the past. He said they have their building now and will have a groundbreaking ceremony on September 9<sup>th</sup>. He said the annual Autumn on the Dry Fork Festival has been held by drive thru for the past 3 years but this year they are going to try to go back to in person. He said it is going to be held on October 15, 2022. He said they will be making apple butter and apple cider on site. They will have music, vendors and chicken and pork dinners. He said any help financially would be appreciated. Commissioner Siler moved to approve the funding request from Dry Fork Recreation Center in the amount of \$2,500.00 and that is to be taken out of the Fairs and Festivals line. All yes – Motion passed unanimously

FUNDING REQUEST FOR CELTIC ARTS FESTIVAL (See copy attached)

Timothy and David Ferguson appeared before the Commission. Timothy Ferguson said he was here at a previous meeting and hoped they considered his request for funding. He said since he was here the last time he has heard that there is now Border collies coming in for a show during their event. He said the event will be held at Camp Pioneer in Beverly, WV on June 17, 2023. He said it is a one day event but will have lots of things going on. He said he hopes to make this an annual event. Commissioner Siler moved to approve the funding request from the West Virginia Wild and Wonderful Celtic Festival and

Highland Games, Inc. in the amount of \$5,000.00 and that is to be taken out of Hotel/Motel tax funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF RECOMMENDATION FROM FIDUCIARY COMMISSIONER ON THE ESTATE OF WILLIAM PAULEY (See copy attached)

County Clerk Brenda Wiseman presented the recommendation to the Commission. She said this is an estate that Jennifer Morgan was appointed over as Fiduciary Commissioner because of conflict in the past over the distribution of guns. She said that issue was resolved and now the estate needs to be settled to sell real estate. She said the Executrix of the estate is now incompetent and cannot sign the final settlement paperwork. The final settlement was presented to Ms. Morgan and was signed by the Guardian for Mrs. Pauley which is not acceptable. The duties of an Executor/Executrix cannot be assigned to a Guardian or Power of Attorney. Ms. Morgan sent that final settlement back. On the following day another final settlement was sent in to the County Clerk's Office and Jennifer Morgan's Office from Hylton Law Office which had the signature of Pearlene Pauley and was notarized and dated August 23, 2022. Ms. Morgan questioned this as Mrs. Pauley has been deemed incompetent and is in a nursing home facility. She said someone needs to qualify as personal representative to close out this estate but she does not feel that it should be the Guardian or the Hylton Law Office. She recommends that the Sheriff of Randolph County be appointed to finalize the estate of William D. Pauley, Jr. and file a Final Settlement. Commissioner Siler moved to approve the recommendation of the Fiduciary Commissioner on the estate of William D. Pauley, Jr. as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM TYGARTS VALLEY BOOSTERS (See copy attached)

Commissioner Siler said he received a call from the Tygarts Valley Boosters that they need a new score board as lightning has struck the old one. He said the cost of the new scoreboard is around \$11,000.00 and that has already been ordered and the Randolph County Board of Education is going to pay for that. He said in the meantime they need something to use temporarily. He said they have ordered a blow up screen, a projector and a tripod. He said the cost for this is around \$1,000.00. They are asking for the Commission's help with the funding for this. Commissioner Siler moved to approve the funding request from the Tygarts Valley Boosters in the amount of \$500.00 and that is to be taken out of Hotel/Motel Tax funds. All yes—Motion passed unanimously

#### Dear Commissioners:

This letter is a request for approval of revenue replacement from ARPA funding to assist the Tygart Valley Homestead Association, a public 501 (c)(3) nonprofit corporation, preserve the legacy and history of the Tygart Valley Homesteads of Dailey, Valley Bend, and East Dailey. Our purpose, as stated in our corporate bylaws, is to address, educate, coordinate, and provide financial support for the preservation of the historic structure, the Homestead Community and Event Center building, within the district served,

TVHA owns and manages the historic Homestead Community and Event Center building, built in 1939 during the FDR "New Deal" era, and the surrounding 17 acres of ground. The facility and grounds are available for community gatherings, educational opportunities, seminars, athletic events, and safety training for our local businesses, law enforcement agencies, and correctional facilities. Our current main objective is to preserve, maintain, and restore the Homestead Community and Event Center building for the use of our area citizens.

Since taking ownership of the Homestead building four years ago, TVHA has secured funding from grants, donors, and raised money from fundraising activities for the following improvements:

- Secured the historic building with cameras, new locks, alarms
- · Replaced the gymnasium and cafeteria roofs
- Upgraded electrical
- Replaced broken windows
- Renovated the kitchen and dining areas
- Purchased new tables and chairs for the dining hall
- Repaired the gymnasium floor
- Added active pathways to the walking track as part of the "Building a Vibrant Community"
- Added a section of fence around the football/soccer field
- Replaced four of the original toilets
- Added additional handicap parking
- Updated gymnasium lights with new energy efficient LED's

The Covid shutdown has negatively impacted TVHA's income for renovation projects, especially the replacement of the second floor and music room roofs. Water continues to leak through causing damage to the ceilings and floors of the historic Homestead building. The second floor remains unusable until the roof is replaced and a fire escape added. Plans for the addition of an ADA compliant restroom on the main level, bathroom and locker room updates, the expansion of more parking area, and the replacement of the gymnasium floor had to all be put on hold due to restricted fundraising activities resulting from the Covid pandemic.

I appreciate your consideration of this revenue replacement funding request.

On August 23, 2022, Tonya Wriston presented to me a Final Settlement, as Guardian for Pearlene Y. Pauley, Executrix for the Estate of William D. Pauley, Jr. Ms. Wriston informed me that Pearlene Y. Pauley was currently in a nursing home facility, incompetent and unable to finish her duties as Executrix. The duties of an Executor/Executrix cannot be assigned to a Guardian or Power of Attorney. Therefore, said Final Settlement was not accepted and returned to Ms. Wriston.

On August 24, 2022, the Randolph County Clerk's Office and subsequently my office received a Final Settlement from Hylton Law Office, PLLC, prepared by and signed by Pearlene Y. Pauley, dated August 23, 2022, attached hereto as Exhibit A. Said document was notarized by Judy Carol Lily of Hylton Law Office, PLLC. After reviewing the signature of Pearlene Y. Pauley on this Final Settlement and prior recorded estate paperwork also signed by Pearlene Y. Pauley, it calls into question the legality of whether Mrs. Pauley actually signed the Final Settlement dated August 23, 2022.

From my conversation with Ms. Wriston, I was under the impression that Mrs. Pauley was unable to leave the nursing home facility, was deemed incompetent and could therefore, not finalize the Estate of William D. Pauley, Jr. Since receiving the second Final Settlement, I have come to the conclusion that neither Tonya Wriston nor the Hylton Law Office, PLLC, are capable of qualifying as appropriate Administrators for the Estate of William D. Pauley, Jr.

### Recommendations to Randolph County Commission for the Estate of William D. Pauley, Jr.:

WHEREFORE, it is my respectful recommendation that the following be approved by the Randolph County Commission in regard to the issues raised by the attempted filing of two Final Settlements:

That Tonya Wriston and Hylton Law Office, PLLC, be prohibited from filing any documents on behalf of or for the Estate of William D. Pauley, Jr.; and

That Pursuant to WV Code 44-1-11 et seq., the Sheriff of Randolph County be appointed as Administrator, to finalize the Estate of William D. Pauley, Jr., and file a Final Settlement.
