Present: Randolph County Commissioners, David Kesling and Chris Siler. Commission President Chris See was absent.

Meeting called to order by Commissioner Kesling

PUBLIC COMMENT:

Richard DeBias appeared before the Commission. He said he has attended about 25 meetings and wanted to come back to recap some issues. He said he asked for a public apology but never received it from anybody. He didn't expect it from the hypocrites. He said the Sheriff and the Prosecuting Attorney do not follow the rules on FOIA requests. He said the City of Elkins does it right and they always answer him. He said the County needs to hire someone to do it for them. He said there is no website for the County and there needs to be one like the City has. He is fed up with all of their policies, he is done and it's a waste of time.

MINUTES:

Commissioner Siler moved to approve the minutes from the regular meeting that was held on September 15, 2022, as submitted. All yes – Motion passed unanimously

REPORTS:

Randolph County Clerk, Brenda Wiseman reported on the General Election. She said the last day to register to vote or make any changes on your voters card is October 18th. She said the poll worker training will be held on October 18th in the courtroom. She said early voting will begin on October 26th and run thru November 5th and it will be held at the Wees Annex and the Russell Memorial Public Library in Mill Creek. She said on Election Night the results will be read in the Courtroom and the canvass will be held on November 14th here in the meeting room beginning at 9 a.m.

ANNOUNCEMENTS:

Commissioner Kesling announced that the next regular meeting will be held on Thursday October 20, 2022 at 1:30 p.m. He also announced that the courthouse complex will be closed on Friday October 7th for the Forest Festival and Monday October 10th for Columbus Day.

The State of West Virginia is going to help with funding like they did last year. She said she has the paperwork that needs signed and sent in for the State funds. She said the State funds will cover the loss of the federal funds for this year. She said she doesn't know how much longer this will continue. REPORT AND RECOMMENDATION

On August 18, 2022 came Claimant Loren Sturms, by his Counsel Jefferson L. Triplett, Esq., Administrator Michael S. White, by his counsel, Steven B. Nanners, Esq. Nancy Yokum, Sherry Streets, Anita Sturms and Milla Scott also appeared pro se to address Claimant's Objection and Petition to Remove Michael S. White as Administrator of the Estate.

Facts |

- Schonna Louise White (decedent) died intestate May 14, 2021, see Randolph County RoD Book 31 at 299.
- 2. Decedent's heirs at law were her four children, namely Michael S. White, Sherry Street (sometimes "Streets"), Loren Sturms and Nancy Yokum, and the children of a fifth deceased child Tammy Taylor, namely Jeffrey Taylor, Paige Cononico and Brittany Taylor, see RoF Book 21 at page 144. (Tammy Taylor's children omitted from that filing).
- Michael S. White was appointed Administrator of Estate of decedent on or about December
 2, 2021, see Fiduciary Order Book 32 at page 433.
- 4. The Petition to remove Mr. White alleges several grounds, including Mr. White's criminal history, his failure to list the property with a realter pursuant to an order of the Circuit Court of Randolph County, and residing at decedent's real estate without paying rent.
- 5. The Petition further alleges that Mr. White has failed to file an Appraisement of the Estate.

** APPROVED BY THE RANDOLPH COUNTY COMMISSION 10-05-2022**

6. Mr. White contends that he has been unable to complete the Appraisement because he had been "working and hadn't had time to do it." Further Mr. White indicated that had been repairing decedent's residence, and compiling the bills of the Estate.

Recommendation

Pursuant to W.Va. Code §44-1-14(a) "[t]he personal representative of an estate of a deceased person shall appraise the deceased's real estate and personal probate property." Further, "[t]he original appraisement form . . . shall be returned to the clerk of the county commission . . . within ninety days of the date of qualification of the personal representative." *Id.* at (f). The ninety-day time limit for filing the Appraisement expired on or about March 2, 2022. It is undisputed that an Appraisement had not been filed as of the August 18, 2022 hearing. The undersigned notes that no Appraisement has been filed as of the date of this Report.

"In cases where the personal representative is nominated by a testator, his desire that a certain person administer his estate should control, if reasonably possible. However, such matters should not prevent the prompt removal of a personal representative who is incompetent, or who fails or refuses to perform his clear duties." *Welsh v. Welsh*, 136 W.Va. 914, 69 S.E. 2d 34 (1952). In this Estate, Michael White was not nominated by the decedent, but the same principal applies. Absent reasonable cause, the failure to file and Appraisement within the ninety-day timeframe of the code is grounds for removal of a personal representative.

Mr. White alleges that he was busy working and had not had time to complete the Appraisement. While laudable, either his other obligations are too numerous for him to be an effective administrator, or he had the time and didn't allocate it wisely. In either event, being busy with work is not a reasonable cause which would not prevent removal.

Further, the allegations that Mr. White was gathering bills and repairing decedent's real estate are not persuasive. The Appraisement is a list of assets, as of the decedent's death. The debts of the estate are not part of the Appraisement. Nor does improving the decedent's real estate, after her death, have any bearing on the date-of-death value of that real estate. Even attributing the best possible intentions to Mr. White, the failure to timely file an Appraisement is not excused by a reasonable cause, in this Estate. Accordingly, the undersigned recommends that Mr. Michael White be removed as administrator of the Estate. If he can otherwise qualify and post bond, Loren Sturms should be permitted to replace him.

The undersigned notes that it is unnecessary to consider the criminal history of Mr. White, the preference of the other heirs, or the allegations of misconduct with respect to decedent's bank accounts. The failure to file the Appraisement is sufficient cause for Mr. White's removal, and while the evidence of the other complaints is a part of the record in this matter, it was not relied upon for the instant recommendation.

It is further appropriate for Mr. Michael White to provide an accounting of all estate assets sold or distributed, as well as all expenses paid by the estate, during his time as administrator. The same should be provided within thirty (30) days of the adoption of this Report by the Randolph County Commission, or the entry of any Order on appeal affirming the removal of Mr. White, whichever is later. The parties exceptions and objections should be preserved as they appear in the record.
